OF
THE AUTHORITY FOR EUROPEAN POLITICAL PARTIES AND EUROPEAN
POLITICAL FOUNDATIONS

of 23 May 2017

to register EUROPEAN PEOPLE'S PARTY

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) No 1141/2014 of the European Parliament and of the Council of 22 October 2014 on the statute and funding of European political parties and European political foundations¹, in particular Article 9 thereof,

Having regard to the application received from EUROPEAN PEOPLE'S PARTY-EUPP,

Whereas:

(1) The Authority for European political parties and European political foundations (“the Authority”) received an application for registration as a European political party under Article 8(1) of Regulation (EU, Euratom) No 1141/2014 from EUROPEAN PEOPLE'S PARTY-EUPP (the ‘applicant’) on 28/04/2017 and a revised version of part of that application on 22/05/2017,

(2) The applicant submitted documents proving that it satisfies the conditions laid down in Article 3 of Regulation (EU, Euratom) No 1141/2014, the declaration in the form set out in the Annex to that Regulation, and the statutes of the applicant, containing the provisions required by Article 4 of that Regulation,

(3) The application is further supported by a statement by notary Kim Lagae pursuant to Article 15(2) of Regulation (EU, Euratom) No 1141/2014 - certifying that the applicant has its seat in Belgium and that the applicant’s statutes are in conformity with the relevant provisions of national law,

(4) The applicant also submitted documents in accordance with Articles 1 and 2 of Commission Delegated Regulation (EU, Euratom) 2015/2401²,

(5) Pursuant to Article 9 of Regulation (EU, Euratom) No 1141/2014, the Authority has examined the application and supporting documentation submitted, and considers that the

applicant satisfies the conditions for registration laid down in Article 3 of that Regulation and that the statutes contain the provisions required by Article 4 of that Regulation,

HAS ADOPTED THIS DECISION:

Article 1

EUROPEAN PEOPLE'S PARTY-EUPP is hereby registered as a European political party.

It shall acquire European legal personality on the date of the publication of this Decision in the Official Journal of the European Union.

Article 2

This Decision shall take effect on the day of its notification.
