AUDITOR'S REPORT

According to the audit mandate, we have audited the financial statements of the *party* prepared by its accountant for the year ending 31/12/2008. Which show a balance sheet total of € 1.211.934,79 and a profit of the year of € 249.383,11.

1. Respective responsibilities of the party and the auditors
